### 1: **Financial Responsibility Kindergarten - 8<sup>th</sup> Grade**

Our tuition for all students grades: **K-4<sup>th</sup> grade \$ 7,250.00** **5<sup>th</sup> - 8<sup>th</sup> grade \$7,300.00** *(includes tech fee)*

Our per-pupil expenditures continue to increase due to inflation and current market trends.

We have included information about how to apply for scholarships through the various programs available through the state of Arizona. We have STO (State Tuition Organization) partners that have provided tuition support to many of our families. Please go to their websites to apply.

Also, include quarterly submissions. Please be aware it is parent responsibility to submit for payment within the given guidelines of quarterly submission. If parent does not meet the quarterly submission timeline, they will be responsible for full quarterly payment of \$ 1812.50 due within 30 days of the quarter end.

\_\_\_\_ **Option C:** Self pay with a minimum **monthly payment of \$ 725.00** (August - May)

**All past due student balances must be paid in full prior to the start of the new school year.**

Failure to meet the financial commitment will result in your account being turned over to the Parish Business Manager for collections. *Failure to meet your financial obligations may also result in your student's inability to return to school.*

Please keep the lines of communication with the school open at all times. It is of utmost importance that all school registration packets and scholarship applications are completed as soon as possible. Please go online to apply for the above STO's or ESA. This will ensure that we are working together to comply with all state requirements.

### 2. **Financial Responsibility Preschool K3 and K4:** (August - May) Full-time students only.

Our preschool rates will remain the same for the coming 2026-2027 school year at **\$175 each week**, which is **\$ 700.00 per month**. Payment must be made in full each month, or your child may be in jeopardy of losing their position in the preschool. You must pay each month even if your child is sick.

### 3. **All After School Care should be paid weekly, if you do not pay monthly.**
